Spotlight on our Education Dept.

For the last three years, Community Educator, Susanne Finn, has been running our **Education Department** and keeping the **Janice W. Gay Library** stocked with plenty of multi-media resources on epilepsy, seizure disorders and disability services.

Susanne's outreach includes participating in a host of health fairs, business fairs and job fairs on a regular basis and attending events like one recently on autism awareness (as seizure is not an uncommon occurrence in autism sufferers). Additionally, Susanne teaches about epilepsy and hosts a support group monthly, at the Palisades Center Mall in West Nyack, for adults and parents of children with epilepsy. Participants are encouraged to share their experiences.

In fact, education at schools is a regular part of Susanne's repertoire. She provides training to staff, teachers, teacher's aids, bus drivers, school nurses and even the PTA. Besides training on epilepsy and first aid for seizures, she also teaches disability etiquette, rights according to the ADA, and other topics.

Susanne is quite creative in her approach to these training sessions. Brian and Joann, a set of large marionette puppets, deliver her important message in a fun and entertaining format. The Kids on the Block TM, as they are known, take an interactive approach to teaching children about seizures, about understanding differences, and about being a good friend.
